#### **INFORMATION ABOUT FEES AND PAYMENTS**

**Tuition and Fees: ACCESS \$3495.00**

**Pricing includes** a non-refundable administration fee of \$200.00

#### **Tuition Payments:**

1. **Deposit of \$1000.00** is due with signing of the enrollment agreement; this includes the **non-refundable administration/registration fee of \$200.00**. We accept the following forms of payment: Cash, Check, Visa, Master card and American Express credit cards.
2. **Balance of Tuition Payment Options (Please select an option below). Let us know your chosen form of payment and which payment option:**
  - **Option #1: Pay in Full and Save \$250.00:** Pay in full at enrollment prior to program start date and receive a \$250.00 discount off of program tuition.
  - **Option #2: Payment Program:** Down payment of \$1,000 with remaining balance due in scheduled payments according to signed extended payment plan. The extended payment plan is based on balance of tuition still owed after the \$1,000 down payment. Payments can be processed two ways: 1) provide post-dated checks that will be deposited monthly according to schedule or 2) we will automatically charge your stored credit card on a monthly schedule. The credit card option includes interest to cover card interchange fees, which will be spelled out on the payment agreement. The full program tuition must be paid no later than the fifth month of the training program. All payment plan payments are scheduled to run on the first of each month. \*Note: the further out from program start date that you make your deposit and enroll, the longer the duration you will have to make payments towards your tuition, therefore making your monthly payments a lesser amount.
    - o **Payment Plan Option with 5 Payments:** a payment amount of \$499 once a month for 5 months total



- o **Payment Plan Option with 10 Payments:** a payment amount of \$249.50 once a month for 10 months total. This payment plan would need to start 5 months before the program start date

**Books:** (Required Reading) are not included in tuition price and can be purchased in the Studio or from another vendor. A book list will be emailed to you prior to the start of the training.

### **Cancellation:**

Evolution Learning Institute makes a substantial commitment of personnel and other resources to provide the Evolution Learning Institute teacher training program to the enrolled applicant. An applicant may ONLY withdraw from the program if written or electronic notice of the withdrawal is received by Evolution Power Yoga no later than 72 hours following the submission of the enrollment agreement and prior to ten days before the start of the program.

*For example: if the application was submitted two weeks before the start of the program, the notice of withdrawal would have to be received within 72 hours of the submission of the application for you to be entitled to a partial refund set forth above. If the application was submitted twelve days prior to the start of the program, the notice of withdrawal would have to be received within 24 hours of the submission of the application for you to be entitled to a partial refund. If the application was submitted 10 days prior to the start of the program there would be no partial refund.*

IT IS UNDERSTOOD AND AGREED THAT THIS IS THE ONLY TIME A REFUND WILL BE GIVEN. ON OR AFTER TEN DAYS PRIOR TO THE BEGINNING OF THE PROGRAM THE FULL TUITION IS DUE AND PAYABLE (OR PAYMENT AGREEMENT IN PLACE) AND NO REFUND WILL BE GIVEN UNDER ANY CIRCUMSTANCES.

With a permitted withdrawal, the applicant will receive a refund of the amount paid, less the \$200.00 nonrefundable administrative fee, within thirty days of receipt of the notice of withdrawal. If unforeseen circumstances prevent participation in current program, the paid funds may be applied to enrollment in a later session of the same program.

**Missed Weekend:** Emergencies and pre-planned events, communicated at the time of enrollment, only are limited to one time. You will not receive your credentialing certificate until the hours are completed.

### **THE STUDENT UNDERSTANDS**

1. Evolution Learning Institute does not accept credit for previous education, training, work experience (experimental learning) or CLEP.
2. Evolution Power Yoga does not guarantee job placement to graduates upon program completion or upon graduation.
3. Evolution Learning Institute/Evolution Power Yoga reserves the right to reschedule the program start date and/or adjust program dates if needed.



4. Evolution Learning Institute/Evolution Power Yoga reserves the right to discontinue the student's training for unsatisfactory progress, nonpayment of tuition or failure to abide by program rules.
5. Upon successful receipt of a "pass" for program completion, participants are qualified to submit for Yoga Alliance 200 Hour trained teacher. A pass is achieved by completing all trainings hours/weekends, receiving a minimum grade of 80% on the midterm, final, teaching practicum, and overall anatomy grade.
